In order to avail this facility, the employee will abide by the under mentioned conditions.

1. Only the employees of the University and their family strictly as per the University Calendar (GNDU, Vol-4; page 233; regulation 1, Medical aid) are eligible to avail this facility, which states as under:

“All officers and employees of the University and their family will be entitled to this facility. The word ‘Family’ shall include (a) wife of University employee (b) in case of woman employee her husband provided he is residing with and totally dependent upon her (c) upto two children, including step/adopted children and (d) parents residing with the employee and totally dependent upon him/her.

No member of the employee family who is in service elsewhere or is engaged in any business will be allowed the benefit of this facility.

- (a) This facility shall also be admissible to retired University employee and his/her dependent wife/husband at the University Health Centre.
 - (b) This facility will also be admissible to widow/widower and minor children of a deceased University employee (who either dies in harness or after retirement)”
2. Reference slip from medical officer of the University Health Centre, duly signed and stamped
 3. Attested photocopy of University Identity Card
 4. Attested photocopy of University Health Centre Medical Card bearing photo graph of employee (in case of his/her own treatment) or photograph of employee and dependent (combined photo, in case of treatment of employees’ s dependent)

Note: Patients are free to get indoor treatment in any hospital of their own choice but the re-imburement of expenses incurred by him/her on his/her treatment will be as per the rates fixed by the Punjab Govt./PGI Chd./or AIIMS New Delhi.
